ORDINANCE NO. 378

AN ORDINANCE PROPOSING TO ANNEX CERTAIN TERRITORY TO THE CITY OF FLORENCE, BOONE COUNTY, KENTUCKY AND SAID TERRITORY BEING CONTIGUOUS TO THE PRESENT CITY LIMITS ON THE NORTHWEST.

THE BOARD OF TRUSTEES OF THE CITY OF FLORENCE, KENTUCKY DOES ORIGIN AS FOLLOWS:

SECTION I

That it deems it necessary and desirable and does hereby propose to annex to the City of Florence, Boone County, Kentucky the following described territory:

Beginning at a point the intersection of the present northwesterly City Limits with the center line of Tanner's Lane; thence

1. Northeasterly at right angle with Tanner's Lane 200 feet with present City Limits; thence
2. Northwesterly and parallel to Tanner's Lane with present City Limits 920 feet more or less to a point 200 feet south of Burlington Pike; thence
3. Southeasterly and parallel to the Burlington Pike with present City Limits 530 feet more or less; thence
4. S 89 - 30 E and parallel with Burlington Pike with present City Limits 2165 feet more or less; thence
5. Southwesterly with present City Limits 900 feet more or less; thence
6. Southeasterly with the present City Limits 400 feet more or less to a point on the projected center line of Center Street; thence
7. S 50 - 8 W with the present City Limits 1504.3 feet more or less to a point in the center of Tanner's Lane; thence
8. S 42 - 45 E with the present City Limits and the center line of Tanner's Lane 300 feet; thence
9. S 67 - 45 E with the present City Limits 314.5 feet; thence
10. S 21 - 45 E with the present City Limits 404.25 feet; thence
11. S 41 E with the present City Limits and the center line of Tanner's Lane 663.7 feet to a point in the center of U. S. Highway 42; thence
12. Northeasterly with the present City Limits and the center of U. S. Highway 42 270 feet more or less; thence
13. S 39 - 22 E with the present City Limits 430 feet more or less; thence
14. Southwesterly and parallel with U. S. Highway 42 1600 feet more or less; thence

15. Northwesterly and at a right angle with U. S. Highway 42 800 feet; thence
16. Northeasterly and parallel with U. S. Highway 42 1700 feet more or less to a point 200 feet east of Tanner's Lane; thence
17. Northwesterly and parallel to the center line of Tanner's Lane 3100 feet more or less to the present City Limits; thence
18. Northeasterly with the present City Limits and at a right angle with Tanner's Lane 200 feet to the beginning.

SECTION II

All ordinances and/or parts of ordinances in conflict herewith are hereby repealed and this ordinance shall be in full force and effect from and after its passage and publication according to law.
