ORDINANCE NO. 0-18-68

AN ORDINANCE REPEALING ORDINANCE NO. 289 WHICH WAS AN ORDINANCE PROPOSING TO ANNEX TO AND MAKE A PART OF THE INCORPORATED TERRITORY OF THE CITY OF FLORENCE, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY CONTIGUOUS TO THE PRESENT CITY LIMITS ON THE SOUTH AND WEST LIMITS OF THE CITY OF FLORENCE, KENTUCKY.

WHEREAS, the Common Council deems it proper that Ordinance No. 289, which was an ordinance proposing to annex to and make a part of the incorporated territory of the City of Florence, Kentucky, certain unincorporated territory contiguous to the present city limits on the south and west limits of the City of Florence, Kentucky, be repealed and rescinded.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FLORENCE, KENTUCKY:

SECTION I

That Ordinance No. 289 heretofore passed by this Council which was an ordinance proposing to annex to and make a part of the incorporated territory of the City of Florence, Kentucky, certain unincorporated territory contiguous to the present city limits on the south and west limits of the City of Florence, Kentucky, be, and the same is hereby repealed.

SECTION II

The territory formerly proposed to be annex by Ordinance No. 289 is bounded and described as follows, to-wit:

Beginning at a point in the existing city limits said point being the point of intersection of the east right-of-way line of LaCresta Drive with the centerline of U.S. Highway 42; thence with the existing city limits and the center line of U.S. 42.

- (1) Southwesterly 1000 feet more or less to the end of the existing city limits; thence
- (2) Southwesterly with the center line of U.S. 42 1600 feet more or less to the existing city limits; thence
- (3) Southwesterly with the existing city limits and centerline of U.S. 42 650 feet more or less to the end of

- the existing city limits; thence
- (4) Southwesterly with the centerline of U.S. 42 300 feet more or less to the east right-of-way of Evergreen Drive; thence
 - (5) Southeasterly with said right-of-way 600 feet more or less; thence
 - (6) Northeasterly 600 feet from an d parallel to the centerline of U.S. 42 2650 feet more or less to the center of Sycamore Drive; thence continuing
 - (7) Northeasterly 600 feet from and parallel to the center line of U.S. 42 1120 feet more or less to a point in the existing city limits; thence
 - (8) N 30 W with the existing city limits 300 feet; thence
 - (9) S 50 - 30 W 152.09 feet to the east right-of-way line of LaCresta Drive; thence
 - (10) N 30 W with the existing city limits 330 feet to the beginning.

SECTION III

All ordinances, resolutions or parts thereof in conflict herewith are, to the extent of such conflict, hereby repealed.

SECTION IV

If any paragraph, section or clause of this Ordinance be held by a proper Court to be invalid, such invalidity shall not affect the remaining sections, paragraphs or clauses, it being hereby expressly declared that the remainder of said Ordinance would have been passed despite such invalidity.
