ORDINANCE NO. 0-20-68

AN ORDINANCE ANNEXING TO AND MAKING A PART OF THE INCORPORATED TERRITORY OF THE CITY OF FLORENCE, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY CONTIGUOUS TO THE PRESENT EASTERLY CITY LIMITS OF THE CITY OF FLORENCE, KENTUCKY.

WHEREAS, the Common Council deems it to be in the best interests of its citizens and for the best interests of persons owning and/or residing in certain hereinafter described unincorporated territory, said territory being adjacent to the present easterly city limits of the City, that said territory be annexed to and become a part of the corporate territory of the City of Florence, Kentucky, and

WHEREAS, this Council has heretofore properly passed an ordinance proposing to annex said territory and said ordinance has been published once a week for four (4) consecutive weeks in the Boone County Recorder, and no protest suit having been filed against said annexation, as required by law.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FLORENCE, KENTUCKY:

SECTION I

That the hereinafter described unincorporated territory lying adjacent to the present easterly corporate limits of the City of Florence, Kentucky, be annexed to and made a part of the corporate territory of the City of Florence, Kentucky.

SECTION II

Said territory hereby annexed is bounded and described as follows, to-wit:

BEGINNING at a point in the existing city limits said point being in the line of the Boone County Board of Education property and being the most southerly corner of Lot 25, Fairview Subdivision; thence with the existing city limits for 2 calls N 32 - 11 W 1127.35 feet to a point in the Tanner tract; thence N 71 - 45 E 348.48 feet to a point; thence S 32 - 00 E 1048.30 feet to a point; thence S 8 - 00 W 99.23 feet to the northeast corner of

Lot 1 of Fairview Subdivision; thence with Lot 1 S 32 - 11 E 254.5 feet to a point in the south right-of-way of U. S. Highway 42; thence S 59 - 45 W 99.64 feet to a point; thence S 52 - 40 W 99.15 feet to a point; thence N 32 - 00 W 264.5 feet to a point in Lot 25; thence with the line of Lot 25 S 58 - 00 30.0 feet to the beginning.

SECTION III

All ordinances, resolutions or parts thereof, in conflict herewith, are to the extent of such conflict, hereby repealed.


SECTION IV


