ORDINANCE NO. 0-38-68

AN ORDINANCE PROPOSING TO ANNEX TO AND MAKE A PART OF THE INCORPORATED TERRITORY OF THE CITY OF FLORENCE, KENTUCKY CERTAIN UNINCORPORATED TERRITORY CONTIGUOUS TO THE PRESENT WESTERLY CORPORATE LIMITS OF THE CITY OF FLORENCE, KENTUCKY. (SUNOCO PROPERTY)

WHEREAS, the Common Council deems it to be for the best interests of its citizens and for the best interests of persons residing in certain unincorporated territory, said territory being contiguous to the present City limits on the west of the city, that said territory be annexed to and become a part of the corporate territory of the city of Florence, Kentucky.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FLORENCE, KENTUCKY:

SECTION I

That it is hereby proposed that the hereinafter described unincorporated territory lying to the west of and being contiguous to the present corporate limits of the City of Florence, Kentucky, be annexed to and made a part of the corporate territory of the City of Florence, Kentucky.

SECTION II

Said territory hereby proposed to be annexed is bounded and described as follows, to-wit:

BEGINNING at a point in the center of U. S. Highway #42, the projection of the east lot line of lot 26 Fairview Subdivision. Thence with the existing City limits N32 - 00W 234.5 feet to a point in lot 25, thence with the line of said lot S58W 60 feet to a point thence southeasterly 240 feet more or less to a point in the center line of said Highway N52 - 40 E 45 feet more or less to the beginning.

SECTION III

It is hereby ordered that this ordinance be published in at least four (4) issues of the BOONE COUNTY RECORDER, Burlington, Kentucky, on each of four (4) separate weekly publications of said newspaper or that copies of this ordinance be posted for at

least ten (10) days in four (4) of the most public places in the City of Florence, Kentucky.

SECTION IV

If, after the aforesaid publication and posting has been done and made and no petition protesting the annexation of the territory herein described, has been filed in the Boone Circuit Court, this City hereby proposes to enact another ordinance annexing to the City of Florence, Kentucky, the above described unincorporated territory, Whereupon, said territory shall become a part of the City of Florence, Kentucky.

SECTION V

All ordinances, resolutions or parts thereof, in conflict herewith, are to the extent of such conflict, hereby repealed.

SECTION VI

If any section, paragraph or clause of this ordinance be held by a proper court to be invalid, such invalidity shall not affect the remaining sections, paragraphs or clauses, it being expressly declared that the remainder of said ordinance would have been passed despite such invalidity.
