

ORDINANCE NO. 0-45-87

AN ORDINANCE RELATING TO THE CLOSING OF A PORTION OF AN ALLEY ON THE NORTHEAST SIDE OF SANDERS DRIVE, KNOWN AS SANDERS DRIVE ALLEY, AND RELOCATING SAME AS A PUBLIC WAY OR ALLEY IN THE CITY OF FLORENCE, KENTUCKY. (WHITTON-PATEL PROPERTY)

WHEREAS, the City Council of the City of Florence, Kentucky, has been requested by the owners of the property abutting certain portions of an alley on the northeast side of Sanders Drive known as Sanders Drive Alley, which is in the City of Florence, Kentucky, to have same closed and relocated as described herein as a public way or alley in the City, and

WHEREAS, the City Council has determined that such closing, and relocation would be consistent with and in the best interests of the public health, safety and welfare of the citizens of the City of Florence, Kentucky, and

WHEREAS, all of the owners of property abutting this portion of Sanders Drive Alley described herein have agreed to consent to the legal measures necessary to close and relocate this public way or alley at no cost to the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF FLORENCE, KENTUCKY AS FOLLOWS:

SECTION I

That a portion of an alley on the northeast side of Sanders Drive, known as Sanders Drive Alley, in the City of Florence, Kentucky, more particularly described in Exhibits "A" and "B" shall be and the same is hereby authorized to be closed and relocated as a public way or alley of the City of Florence, Kentucky.

SECTION II

That the portion of Sanders Drive Alley on the northeast side of Sanders Drive in the City of Florence, Kentucky, more particularly described and shown on a plat marked as Exhibit "B", shall be and the same is hereby authorized to be closed and relocated as a public way or alley of the City of Florence, Kentucky.


SECTION III

That this Ordinance is enacted in conformance with K.R.S. 82.405 and other applicable law and the appropriate officials of the City of Florence, Kentucky are hereby authorized and directed to take all legal steps necessary under Kentucky law for the closing and relocation of this public way or alley as described and shown herein and in Exhibit "A" and Exhibit "B". This is on condition that the owners of all lots abutting said public way or public alley agree to said closing and to pay the costs thereof.
