The Boone County Fiscal Court was called to order by Judge Bruce Ferguson on Tuesday, June 1, 1976 at 10:00 A.M. in the Fiscal Courtroom, Burlington, Kentucky.

A motion was made by Galen McGlasson, seconded by Dick Houston, all voting AYE approving the minutes of the Fiscal Court meeting held May 18, 1976.

Dick Houston presented a thank you card from Mr. & Mrs. Jerry Cahill and the residents of McCoys Fork Road for the reconstruction of the road.

Jay Liver informed the Court that Browning-Ferris has blacktopped their area upon the completion of the blacktopping of McCoys Fork Road. This will track less mud on the road.

Jay Liver recommended to the Court that a speed limit of 35 MPH be set on McCoys Fork Road. A motion was made by Dick Houston, seconded by Galen McGlasson, all voting AYE establishing the speed limit of 35 MPH on McCoys Fork Road.

A Public Hearing was held regarding the proposed closing of Flintlock Drive (right-of-way-Boone Creek Subdivision). Jay Liver presented the viewers report recommending that said right-of-way be closed. There were no objections to the closing. A motion was made by Galen McGlasson, seconded by Dick Houston, all voting AYE to close Flintlock Drive as shown on the plat for Boone Creek Subdivision.

A Public Hearing was held regarding the proposed closing of Alley 13 in Burlington. Jay Liver presented the viewers report recommending that said Alley 13 be closed. There were no objections to closing this road. A motion was made by Galen McGlasson, seconded by Ken Lucas, all voting AYE to close Alley 13 in Burlington.

Ed Ashcraft presented the Court with his plans for a Senior Citizen Residential Facility in Walton. He explained to the Court what he was doing and how the project was being handled. He noted the great need for adequate housing for senior citizens. Mr. Ashcraft stated that he has applied to HUD for the Section 8 Housing Assistance program. All of the senior citizens would be eligible, due to the fact that they are in the low or moderate income bracket. He stated that at this time he is constructing a 31 unit facility. The Court commended Mr. Ashcraft for his work and approves and endorses the project.

Harold Scroggins presented the Court with a petition from the residents on Porter Road, requesting that the road be repaired. He stated that it is almost impassable and full of holes. Jay Liver informed the Court that at one time the road had been tarred & chipped and later gravel had been put on the road. He stated that the gravel will not stay on the road due to the tar & chip. He stated that the only thing that can be done now is to patch the road with blacktop rather than gravel. Jay stated that the blacktop would stay on the road and hold up better. Jay also stated that he would have stone put on the 300 ft. section at the end of the road. Jay Liver informed the Court that he and Tom Schwartz would drive the road and make recommendations as to the speed limit at the meeting to be held June 22, 1976.
