Upon being moved and duly approved this 21<sup>st</sup> day  
of October, 1975.

IT IS HEREBY ORDERED by the Boone County Fiscal  
Court that the following described abandoned county roads and  
extensions thereof be permanently closed:

ABANDONED COUNTY ROADS

Being the entire right of way of certain county roads  
located in the "First Addition to Skyway Subdivision"  
as recorded in Plat Book 3, page 37 of the Boone  
County Clerk's records at Burlington, Kentucky, and  
described as follows:

1. West Delta Road from the westerly right of way of  
Curtis Street northwest for a distance of approxi-  
mately 1,048 feet; thence a northeasterly direction  
for a distance of approximately 350 feet to a point  
in the southerly right of way line of Airway Drive.
2. Bellanca Road from its intersection with West Delta  
Road southwesterly for a distance of approximately  
870 feet to the northerly right of way line of  
Donaldson Highway as relocated (Ky. Route 236),  
such point being the same as that as described in  
the Order of the Boone County Fiscal Court dated  
the 5th day of September, 1972.
3. Lakewood Drive from its intersection with Bellanca  
Road southeasterly for approximately 175 feet to  
the easterly boundary of the subdivision.
4. Convair Place from its intersection with Bellanca  
Road southeasterly approximately 175 feet to the  
easterly boundary of the subdivision.

5. Curtis Street from its intersection with West Delta Road southwesterly approximately 225 feet to the southerly boundary of the subdivision.

#### UNDEDICATED STREET EXTENSIONS

In addition to the above abandoned roads, there are certain deed references to future extensions of Convair Place and Curtis Street, beyond the subdivision boundary, that are also abandoned and should be closed.

The description for these street extensions are as follows:

1. The extension to the east of Convair Place for approximately 765 feet from the easterly boundary of the First Addition to Skyway Subdivision to its intersection with Curtis Street extended of the same subdivision, said right of way being 50 feet in width.
2. The extension to the south of Curtis Street for approximately 185 feet from the southerly boundary of the First Addition to Skyway Subdivision to its intersection with Convair Place extended of the same subdivision, said right of way being 50 feet in width.

The above described abandoned county roads and extensions thereof are permanently closed. All rights and upkeep to said county roads and extensions thereof within the entire right of way shall by this action be removed from public responsibility.
