Upon being moved and duly approved this 17th day of March, 1981.

IT IS HEREBY ORDERED by the Boone County Fiscal Court that the following described abandoned county road be permanently closed:

Located generally in Groups N. 2026, 2027, 732, 750 and 1011 of the Boone County Clerk's records in Burlington, Kentucky and being a thirty (30') foot right-of-way. The centerline of said thirty (30') foot right-of-way being more particularly described as follows:

Beginning at the centerline intersection of the now existing (1980) Price Pike with Zig Zag Road, thence N-40-36'-W along the centerline of Price Pike a distance of 411.0 feet to the true place of beginning; said point also being a common corner to Kenton County Airport Board, Inc. property and Genie T. Kothmann (Lot #14 - Happy Acres Subdivision); thence continuing along the centerline of Price Pike for fifteen (15) calls;

- N-40-36'-W a distance of 738.15 feet;
- N-39-13'-W a distance of 108.00 feet, said point shall hereinafter be referred to as Reference Point "A";
- N-39-13'-W a distance of 191.00 feet to a point, said point shall hereinafter be referred to as Reference Point "B";
- N-39-13'-W a distance of 56.69 feet to a point;
- N-35-36'-W a distance of 415.00 feet to a point, said point shall hereinafter be referred to as Reference Point "C";
- N-35-36'-W a distance of 84.49 feet;
- N-51-41'-W a distance of 168.35 feet;
- N-56-57'-W a distance of 148.58 feet;
- N-52-37'-W a distance of 28.00 feet to a point, said point shall hereinafter be referred to as Reference Point "D";

N-52-37'-W a distance of 549.30 feet;  
N-65-14'-W a distance of 387.30 feet;  
N-50-32'-W a distance of 282.91 feet;  
N-59-34'-W a distance of 264.52 feet;  
N-71-38'-W a distance of 1035.50 feet;  
N-40-49'-W a distance of 2849.90 feet;  
to a point in the centerline of Anderson Ferry Road.

The right-of-way to be closed widens to twenty five (25) feet on the west or left side of the line connecting aforementioned Reference Points "A" and Reference Point "B" and also widens to twenty five (25) feet to the west or left side of the lines connecting aforementioned Reference Point "C" and Reference Point "D".


The above described abandoned county road is permanently closed. All rights and upkeep to said county road within the entire right-of-way shall by this action be removed from public responsibility.
